



Biographies CAW-TCA

Peter Kennedy is the CAW National Secretary-Treasurer. Before becoming one of the union's top officers, Peter was the assistant to the Secretary-Treasurer where he oversaw negotiations with

General Motors, the aerospace sector and the electrical and electronic sectors. In this capacity, he was also responsible for day to day operations and administration of the union, retirees programs as well as staff relations. Peter has sat on the board of directors for a number of community organizations and led a number of provincial and federal electoral campaigns.

Sylvain Martin is the CAW Quebec Director and the regional director for the Quebec City area. Through-out his years as a union member and activist, Sylvain has held a number of elected positions in the local union and served as president of the Quebec Council, considered to be the parliament of the Quebec-based section of the union. As a union staff member, Sylvain has worked in education, organizing and servicing.

Deb Tveit is an assistant to the CAW National President. Deb became a member of the union after helping organize her workplace in 1990. Before being named assistant, she held a number of elected positions and later was appointed as a national service representative. As an aboriginal worker of the Oneida Nation, Deb has been active in improving the rights and position of aboriginal and workers of colour within the union, workplaces across the country and the broader community.

Bob Chernecki is the recently retired assistant to the CAW National President. Bob was appointed as assistant in 1992 and served under two national presidents. He was responsible for major collective bargaining at Chrysler, Ford, CN, CP, VIA Rail, skilled trades, the ship building, fisheries, and the health care sectors, along with other responsibilities out of the president office. Before joining the staff of the union in 1987, Bob held various local union elected positions at CAW Local 444 in Windsor, Ontario.

Tim Carrie is the president of CAW Council, considered to be the parliament of the union. He is also the president of CAW Local 27 in London, a large amalgamated local union with members in auto parts, health care, general manufacturing and warehousing. Tim is the president of the CAW Independent Parts Supplier Council (IPS Council) and a member of the CAW's National Executive Board. Tim served as president of the London District Labour Council.

Lewis Gottheil is the Director of the CAW Legal Department, which operates out of Toronto and Montreal. Lewis advises the leadership and staff of the CAW on a broad range of legal issues that impact the union and its membership at the bargaining table, in the workplace, and in the community at large. He appears as litigation counsel to defend and advance the legal interests of the union before all employment related Tribunals and all levels of provincial and federal Superior and Appellate Courts. Lewis graduated from McGill University, B.A. (Great Distinction) in 1977 and Osgoode Hall Law School in 1980, and was called to the Bar in 1982.
